Acknowledgment and Disclosure of Team Members

We, the undersigned members of _____, a team participating in Go Code Colorado (“We” or the “Team”), hereby represent and warrant that the names and signatures of all the members of the Team that materially contributed to the creation of our competition entry (“Entry”) in accordance with the requirements of the Go Code Colorado Official Participant Rules 2018 (the “Rules”) are set forth below, and that we are eligible to compete in the Go Code Colorado challenge.

We acknowledge and agree that Go Code Colorado will pay our cash award of two thousand five hundred dollars (\$2,500) in equal amounts to each team member individually following Mentor Weekend (April 27-29), contingent upon each team member providing Go Code Colorado with a complete and accurate Form W-9. We further acknowledge and agree that payments to individual team members will include travel reimbursement for travel to and from Mentor Weekend, contingent upon each team member providing Go Code Colorado with a complete and accurate Form W-9 and complete and accurate documentation of all actual and reasonable travel expenses.

In the event any team member is under the age of eighteen (18), any payments to such member are further contingent upon such member providing proof of parental consent to receive such payment.

The Team and Go Code Colorado both acknowledge and agree that the Team may add or remove members of the Team prior to the Final Competition, provided that any member added sign an Acknowledgement and Disclosure, and following execution of this Acknowledgement and Disclosure will be ineligible for cash awards earned by the Team on Challenge Weekend.

We forever release Go Code Colorado and its officers, directors, agents, affiliates, and employees from claims, controversies, causes of action, damages, losses, liabilities, injuries, obligations, assertions, contentions, and demands, known or unknown, suspected or unsuspected, of any kind we may have, own, or hold at any time against Go Code Colorado related to our failure to disclose all of the members of the Team that materially contributed to the creation of our Entry.

We agree to jointly and severally defend, indemnify and hold Go Code Colorado and its officers, directors, agents, affiliates, distributors, and employees harmless against any loss, damage, expense, or cost, including reasonable attorneys’ fees (including allocated costs for in-house legal services) (collectively, "Liabilities") arising out of the following claims, demands, proceedings, or lawsuits by a third party: (1) Liabilities related to disputes between team members; (2) Liabilities related to disputes between team members and their employers; (3) Liabilities related to infringement of any copyright, trademark, or any other intellectual property right; or (4) Liabilities arising out of our failure to disclose all the members of our Team that materially contributed to the creation of our Entry.

Any dispute relating to or arising out of the application, interpretation, or enforcement of this Agreement will be governed by the laws of Colorado without the conflict of law provisions therein. If any portion of this agreement is deemed invalid, the remainder will continue in full force and effect. If any provision of this agreement is declared by any court of competent jurisdiction to be illegal, void, or unenforceable, all other provisions of this agreement shall not be affected and remain in full force and effect.
